## Explanatory Notes

1. The main purpose of compiling this Monthly Bulletin is to show the general situation of Changhua county. It is intended to provide data for decision-making.
2. The measure units used in this Monthly Bulletin are of metric system and the currency unit is N.T.\$. If the figures in the table are long, we lift the unit count 5 and higher fractions as units and disregarding the rest. Therefore the total number doesn't always coincide with the detail number.
3. The following symbols are used for tables:
  - ” - ” means no figures.
  - ” ... ” means figures not yet available.
  - ”0” means figure is below half a unit.
  - ”--” means figure provided are meaningless.
4. The figures given in this issue may not agree with the corresponding figures in the previous issue. The figures given in this issue is correct.

Figure 1-1 Population in Changhua County




圖1-2 彰化縣自然增加率及社會增加率

Figure 1-2 Rate of Natural-Increase and Social-Increase in Changhua County



## 二、商業登記

本縣107年9月底之商業登記家數及資本額分別為36,621家及7,999,193千元，與上月底比較，分別增加0.17%及0.20%。

各行業中以批發及零售業20,828家，約占56.87%最多，製造業4,663家，約占12.73%次之。而資本額亦以批發及零售業3,285,940千元，約占41.08%最多，製造業1,559,677千元，約占19.50%次之。



### 三、工廠登記

本縣107年9月底工廠登記家數為10,600家，與上月底比較，登記家數增加0.26%。

各行業中以金屬製品製造業3,897家，約占36.76%最多；塑膠製品製造業及機械設備製造業各為1,026家，約占9.68%次之。




圖3-2 彰化縣工廠登記家數  
Figure 3-2 Number of Registered Factories




圖3-3 彰化縣工廠登記家數各行業所占比率 (107年9月底)

(End of Sept., 2018)




## 四、公司登記

圖4-1 彰化縣公司登記家數各行業所占比率 (107年8月底)


Figure 4-1 Rate of Various Industries in Registered Companies by Organization

Figure 4-2 Number of Registered Companies by Organization






(Aug., 2018)



(Jan. ~Sept., 2018)




圖7-2 彰化縣刑事案件破獲率（107年1~9月）

Figure 7-2 Clearance Rate in Changhua County (Jan. ~Sept., 2018)


