2. The measure units used in this Monthly Bulletin are of metric system and the currency unit is N.T\$. If the figures in the table are long, we lift the unit count 5 and higher fractions as units and disregarding the rest. Therefore the total number doesn't always coincide with the detail number.




## 二、商業登記

本縣108年12月底之商業登記家數及資本額分別為37,790家及83億3,879萬元，與上月底比較，分別增加0.11%及0.20%。

各行業中以批發及零售業21,072家，約占55.76%最多，製造業4,870家，約占12.89%次之。而資本額亦以批發及零售業33億5,577萬元，約占40.24%最多，製造業16億5,309萬元，約占19.82%次之。





### 三、工廠登記

各行業中以金屬製品製造業4,210家，約占38.14%最多；塑膠製品製造業1,056家，約占9.57%次之。




圖3-2 彰化縣工廠登記家數  
Figure 3-2 Number of Registered Factories




圖3-3 彰化縣工廠登記家數各行業所占比率 (108年12月底)

(End of Dec., 2019)






本縣108年11月底之公司登記家數及資本額分別為27,328家及4,753億5,800萬元，與上月底比較，分別增加0.16%及0.40%。


圖4-2 彰化縣公司登記家數




## 六、歲出預算執行概況

本縣108年度總預算截至11月底之歲出預算累計執行率(累計執行數/累計分配數)為79.03%，其中經常門90.46%，資本門40.16%。

排除「統籌支撥科目」，經常門以民政處主管94.33%最高，資本門以地方稅務局主管97.23%最高。而本府主管部分，經常門為91.98%、資本門為40.83%。

(Nov., 2019)



(Jan.-Dec., 2019)




圖7-2 彰化縣刑事案件破獲率（108年1~12月）  
Figure 7-2 Clearance Rate in Changhua County (Jan.-Dec., 2019)






## 八、資源回收

本縣108年11月份資源回收共計2萬3,898公噸，其中以紙類8,852公噸最多，約占37.04%。

## 九、稅捐徵收

截至108年12月底止，本縣縣稅之實徵淨額為124億5,178萬元，累計徵收率(累計實徵淨額/累計分配預算數)為109.06%，實徵淨額較上年同期減少1億1,898萬元(或0.95%)。累計實徵淨額以使用牌照稅39億1,453萬元，約占31.44%最多；房屋稅28億6,915萬元，約占23.04%次之；土地增值稅27億4,056萬元，約占22.01%再次之。



