


二、商業登記

本縣111年3月底之商業登記家數及資本額分別為41,169家及91億8,788萬元，與上月底比較，分別增加0.87%及0.61%。

各行業中以批發及零售業21,769家，約占52.88%最多，製造業5,856家，約占14.22%次之。而資本額亦以批發及零售業35億6,857萬元，約占38.84%最多，製造業19億3,926萬元，約占21.11%次之。





各行業中以金屬製品製造業4,783家，約占40.42%最多；塑膠製品製造業1,089家，約占9.20%次之。




圖3-2 彰化縣工廠登記家數
Figure 3-2 Number of Registered Factories




圖3-3 彰化縣工廠登記家數各行業所占比率 (111年3月底)

(End of Mar., 2022)






圖4-2 彰化縣公司登記家數
Figure 4-2 Number of Registered Companies by Organization




圖4-3 彰化縣公司登記資本額
Figure 4-3 Capital of Registered Companies by Organization



截至111年3月底止，本縣縣稅之實徵淨額為12億5,984萬元，累計徵收率（累計實徵淨額/累計分配預算數）為142.84%，實徵淨額較上年同期增加1億2,876萬元（或11.38%）。累計實徵淨額以土地增值稅6億8,594萬元，約占54.45%最多；使用牌照稅3億2,939萬元，約占26.15%次之；印花稅1億423萬元，約占8.27%再次之。



