


二、商業登記

本縣112年12月底之商業登記家數及資本額分別為43,504家及99億883萬元，與上月底比較，分別增加0.14%及0.45%。

各行業中以批發及零售業22,533家，約占51.80%最多，製造業5,905家，約占13.57%次之。而資本額亦以批發及零售業38億2,888萬元，約占38.64%最多，製造業20億6,743萬元，約占20.86%次之。





(End of Dec., 2023)




圖3-2 彰化縣工廠登記家數
Figure 3-2 Number of Registered Factories




圖3-3 彰化縣工廠登記家數各行業所占比率 (112年12月底)

(End of Dec., 2023)



四、公司登記




圖4-2 彰化縣公司登記家數
Figure 4-2 Number of Registered Companies by Organization




圖4-3 彰化縣公司登記資本額
Figure 4-3 Capital of Registered Companies by Organization






六、歲出預算執行概況

本縣112年度總預算截至11月底之歲出預算累計執行率(累計執行數/累計分配數)為83.30%，其中經常門88.97%，資本門48.78%。

排除「統籌支撥科目」，經常門以地方稅務局主管92.31%最高，資本門以民政處主管99.16%最高。而本府主管部分，經常門為88.41%、資本門為48.32%。

(Nov., 2023)



八、資源回收

九、稅捐徵收

截至112年12月底止，本縣縣稅之實徵淨額為120億6,541萬元，累計徵收率（累計實徵淨額/累計分配預算數）為105.59%，實徵淨額較上年同期減少1億2,774萬元(或1.05%)。累計實徵淨額以使用牌照稅40億3,296萬元，約占33.43%最多；房屋稅30億6,695萬元，約占25.42%次之；地價稅23億1,507萬元，約占19.19%再次之。

(End of Dec., 2023)




圖9-2 彰化縣縣稅累計實徵結構 (112年12月底)

(End of Dec., 2023)


